Each indoor market space is 10'x10'. Vendors may need to provide their own table(s), as a limited number of picnic tables are available. Seasonal pricing guarantees the same space each week and at least one (1) promotional posting on SRCC's Facebook page during the regular season. WEEKLY Vendor Rate: \$35.00 per space per week. As a vendor wishing to rent space in the Speculator Farmers and Crafters Market, I agree to save, hold harmless, and indemnify the market, The Village of Speculator, Speculator Chamber of Commerce, members and employees from any liability or responsibility pertaining to any damages to person or property on-site leased by me from the said market, when such damages, or liability, arising out of any acts of my own, or my employees or associates, located at said site. I agree to operate my booth safely and courteously and pay rent as set forth by this agreement. I understand that failure to comply with the market Rules and Regulations could result in my dismissal from the market.
