Note: If any of the above paperwork, certificates, or licenses are not submitted to the Adirondacks Speculator Region Chamber of Commerce by the stated deadline, the festival reserves the right to prohibit the vendor from participating.

Speculator Region Wine & Bear Festival Contract

- The FESTIVAL will provide -

- A 10' x 10' space is available for a fee of \$150 (Early bird discount \$100 if paid by April 15th).
- Mention of each vendor on the website and Facebook once the completed application is received and accepted.
- Tasting cups for samples.
- Checking the IDs of attendees and wristbands.

VENDORS are responsible for adhering to all event regulations, including:

MARKETING LICENSE: All vendors must provide a copy of their applicable and valid NYS liquor & tasting/marketing permit with their application. The license must be on display at your booth.

SALES TAX: All vendors selling taxable merchandise must display a validated sales tax certificate of authority. A copy must be submitted with your application and displayed at your booth.

INSURANCE: All vendors must provide an Agreement of Comprehension General Liability Insurance including Liquor Liability (if applicable) naming **Adirondacks Speculator Region Chamber of Commerce**, PO Box 184, Speculator, NY 12164, and the **Village of Speculator**, 2885 Rt. 8, Speculator, NY 12164 as additional insureds for a minimum of \$1,000,000.00 per occurrence and \$2,000,000.00 general aggregate, and \$1,000,000.00 liquor law liability. All insurance shall waive subrogation against the same entities.

WORKER'S COMP: Proof of Worker's Comp insurance must be provided to the festival unless the business is exempt.

SAMPLING: Vendors must offer complimentary samples of their products to attendees.

SALES: All vendors are to promote sales of their products for off-premises consumption only.

BOOTH: All vendors must provide their booth set-up (signage, tables, tablecloths, chairs, etc.

STAFFING: All vendors must provide their staffing for the event. We highly encourage at least two staff members to handle sampling and sales properly to increase customer satisfaction and sales. Staff must be TIPS certified.

SET-UP: Set-up will begin after 9:30 am on the festival day.

BREAKDOWN: Breakdown cannot begin until 4:15 pm (even if products are sold out).

PARKING: Vendor vehicles and trailers must be parked in the designated Vendor Lot after load-in.

PLEASE NOTE:

- There is no WIFI at the Festival, but cellular service is generally available, depending on your provider.
- This is a RAIN or SHINE event. Booth reservations are non-transferable and non-refundable.
- This event will also include craft and other vendors.
- Vendors will be accepted on a first-come, first-served basis, and the 'Bear' and Wine Festival reserves the right to accept or reject applications based on guidelines, goals, and expectations for the event.
- Vendor contact information may be shared with festival attendees and sponsors where applicable.
- Failure of the vendor to provide the necessary and required paperwork by stated deadlines may result in the vendor being denied participation in the festival.
- Vendor shall indemnify and hold harmless the Adirondack-Speculator Region Chamber of Commerce and the
 Village of Speculator, their officers, directors, members, agents, employees, subcontractors, volunteers, and
 their successors and/or assigns from any loss, claims, liability, physical injury, damages or expenses (including
 reasonable attorney fees) they may suffer in connection with the festival, caused or contributed to by vendor, its
 officers, members, agents, employees, subcontractors, and volunteers.
