FESTIVAL RULES & REGULATIONS

<u>Licenses, Certificates, and/or Insurance</u>: The vendor must provide proof of any **required** certificates and/or insurance. Non-food vendors are exempt from having insurance unless otherwise stated. Vendors will provide copies of the certificate of insurance naming the Adirondacks Speculator Region Chamber of Commerce, 2960 Route 30, PO Box 184, Speculator, NY 12164, <u>and</u> the Village of Speculator, 2875 Route 8, PO Box396, Speculator, NY 12164, as additionally insured, if needed. The minimum amount of insurance will be \$1,000,000.00.

<u>Set Up</u>: Each vendor will be responsible for all equipment and supplies for setting up a booth. Displays should be constructed so that they do not block customer walkways or pose any other hazard to customers. Vendor start-up may commence on Saturday, September 21, at 9 a.m.

<u>Clean Up:</u> Vendors are required to keep their space neat and clear of any obstacles, litter, and debris. Upon completion of the event, the facilities must be left clean. No portion of a vendor's inventory, equipment, or any other structure shall be left overnight on the site. **Breakdown may commence at 4:00 PM and must be completed by 6:30 PM on Saturday, September 21.**

<u>Motorized Vehicles</u>: Motorized vehicles are prohibited from Public Property designated as walkways and grass-covered areas except designated parking areas.

<u>Weapons, Firearms, or Fireworks</u>: No person shall possess or discharge weapons, firearms, or fireworks in any Village park.

<u>Customer Treatment</u>: Vendors are expected to treat customers in a courteous manner. No form of discrimination is permitted during this event.

AGREEMENT

I/we have read and agree to conform to the above rules and conditions for the use of the Public Park/Ball Field areas located in the Village of Speculator during the Speculator Region Bear & Wine Festival, sponsored by the Adirondacks Speculator Region Chamber of Commerce.
