

**Town of Inlet/Webb
Snowmobile Trail Permit Fee and Information**

Thank you for inquiring about Snowmobile Permits. Attached is an application form. Please read it carefully and fill in all information.

Permit Rates Per Machine:

- Preseason: \$65 (**Must be postmarked March 15 - November 15**)
- Season: \$80
- Weekly: \$45 (Must be purchased in person. Valid 7 consecutive days from the date of purchase. Mail orders not accepted.)
- Weekday: \$50 (Good for entire season. Valid **ONLY** Sunday 5:00 p.m. - Friday 5:00 p.m.)

Policies for Towns of Webb & Inlet Snowmobile Trail Permits:

- **NO REFUNDS.**
- Permit stickers **must be displayed** on the driver's side of windshield.
- VINs are required to issue a permit. If you are purchasing a new snowmobile and wish to take advantage of our preseason rate, you can purchase your permit by November 15th and your sticker will be held until the VIN is provided. It is YOUR responsibility to provide the VIN and insure that the VIN on the paper part of your permit matches the VIN on the snowmobile to which the sticker is attached.
- Permits should be purchased by or in the name of the owner of the snowmobile whose name appears on the New York State registration. Permits are not transferable.
- **Replacement stickers** can only be issued (one time only) if the old sticker with the number visible is presented. (Old stickers can be removed by applying heat, as with a hair dryer.) A replacement sticker will not be issued without receiving the old sticker first.
- To upgrade a Weekly permit to a Seasonal permit, the paper part of the permit should be submitted.

Trail Information:

- This Trail Permit is valid on the Webb/Inlet Snowmobile Trail Systems. You must comply with NYS laws and regulations. Observe all trail, posted and speed limit signs. Violators will be prosecuted.
- Old Forge airport is off limits.

If you need more applications, feel free to make photocopies. Please print on the application - this will make our process more efficient. Do not forget to sign the bottom of your application.

Snowmobilers are reminded that liability insurance is required by NYS to operate snowmobiles on lands and roads not personally owned or leased.

Please also remember that you must register your snowmobile through New York State to operate it in New York State. There is no reciprocity with other states. For New York State registration information call 518-548-7111 or go to the New York State DMV website at www.nysdmv.state.ny.us.

Please note that mailed applications may take up to two weeks to be processed once received.

RESPONSIBILITIES AND ACKNOWLEDGEMENT OF RISK

In consideration of being permitted to use the snowmobile trails promoted and maintained by the Towns of Webb/Inlet, I expressly acknowledge:

1. That in compliance with New York State law(s), the snowmobile(s) listed above has the required New York State registration(s) and liability insurance;
2. That I agree to abide by any and all notices posted from time to time by the Towns of Webb/Inlet which may pertain to my responsibilities as a snowmobile operator, and I will ride only on trails designated by the Towns of Webb/Inlet;
3. That trail conditions vary constantly because of weather changes and snowmobile use. I also understand that ice, variations in terrain, moguls, rocks, forest growth, debris, and other obstacles and hazards, including other snowmobilers, exist throughout the area. Therefore, I acknowledge that the sport of snowmobiling is a hazardous activity and that I could suffer personal injury as a participant.

I hereby expressly acknowledge my understanding and acceptance of the forgoing, and agree to assume the risk of any personal injuries I may incur during my use of the Town of Webb/Inlet snowmobiling facilities.
